If the event is cancelled, ONN shall refund all registration fees paid, but shall not be held liable for hotel, airfare, or other costs incurred by attendees.

ONN shall not be held liable for (and shall be entitled to use) any photos or videos taken of participants or event proceedings for promotional purposes.

Privacy policy

Registration confirmation and payments

Event attendees will receive email confirmation after completing their online registration and a payment receipt will be sent by email only following full completed payment. Only those attendees who have completed registration, and have paid in full will be able to attend the event, unless previous financial arrangements have been made with ONN.

Registration can be paid online via credit card (Visa or Mastercard) on Eventbrite. If paying by credit card is not an option for your organization, please contact admin@theonn.ca for alternative options.

Registration substitution

Registrants unable to attend may send a substitute. If the substitute is not an ONN member, the non-member fee will be charged. Substitutions must be made in writing to admin@theonn.ca. Substitutions will be accepted up to two weeks in advance of the event date. Substitutions after this date may not be accommodated. Please note that it is the responsibility of the substitute to reach out to admin@theonn.ca to inform ONN of any dietary needs and accommodations they may require.

Cancellation and refunds

Full event registrations, less the Eventbrite fees, are refundable if submitted in writing to admin@theonn.ca up to one week in advance of the event date. Refunds will be issued within 30 days of the cancellation date. In most cases, refunds will be issued back in the original payment.

Registrations and cancellations received after that point are not refundable.

Accessibility

Event attendees may inform ONN of any accommodations requests (example: ASL interpretation, large-print agenda, etc.) through the registration form. Attendees may also reach out to admin@theonn.ca directly with requests. Please keep in mind that if the request is made close to the event date, we may not be able to guarantee it will be fulfilled. Please refer to the specific registration page for deadlines.

Any accommodation requests will be confidential. An ONN staff member may reach out for clarification or to provide further information in advance of the event. Questions related to

accessibility and accommodation can be directed to admin@theonn.ca.

Each venue for Nonprofit Driven Regional Connects will vary by location. Venue and accessibility information will be present in each registration page.

Free admission will be provided to healthcare aide attendants, interpreters, and/or translators accompanying attendees. In order for ONN to have final attendance numbers, please indicate who will be accompanying you on your registration form or reach out to admin@theonn.ca.

Dietary requests

Event attendees may inform ONN of any dietary requests for food served during the event directly through the registration form. Attendees may also reach out to admin@theonn.ca directly with requests. Deadlines to guarantee requests can be met will be clearly outlined in each event's registration page. After the deadline, we may be unable to accommodate new requests that come in.

Dietary requests will be kept confidential.

Scent policy

To support the creation of a fragrance-free environment so that chemical barriers will not prevent access to the event, we request that participants refrain from the following before or during the event: smoking, wearing colognes, perfumes or scented oils. We kindly ask participants to wear something that has had limited exposure to the items above, if possible.

Venue code of conduct

Event participants are expected to abide by the code of conduct of the particular venue the event is being hosted at.

Anti-harassment policy

ONN is committed to a trusting, safe work environment free from violence and harassment, extending to any gatherings and events ONN hosts. Any act of violence or harassment is unacceptable. This includes the prohibition of discrimination of any kind.

No solicitation policy

To maintain a smooth and respectful event experience, solicitation of any kind is not permitted at ONN events. This includes individuals or groups soliciting attendees, vendors, or staff for business, donations, or other purposes.

COVID policy

We recognize that COVID-19 continues to be a concern in our communities. Taking precautions to prevent the spread of COVID-19 helps us protect and care for one another.

Masking policy: We recognize that masks are no longer mandatory in public spaces in Ontario. However, it is still encouraged to wear masks in gathering spaces. Masks will be available at the registration desk. No harassment of those wearing masks will be tolerated.

Vaccination policy: As per ONN's policy, all in person events or meetings (on-site or off-site) that ONN hosts and manages strongly suggest attendees to have full vaccination against COVID-19. We use the Ontario government's definition of "fully vaccinated". Please see the <u>"Fully Vaccinated"</u> section of this webpage for more information.

Screening, symptoms & refunds: Please do not attend Nonprofit Driven Regional Connects if you have symptoms of COVID-19 and are testing positive for COVID-19, or if you have any other symptoms of contagious illness. A list of symptoms of COVID-19 are here. Registration cancellations due to COVID-19 or other illnesses will be issued a full refund. Please contact admin@theonn.ca.

Risk and other considerations: While we have policies in place to help prevent the spread of COVID-19 at the conference, we recognize that the risk of infection cannot be completely eliminated. Everyone who attends a Nonprofit Driven Regional Connects event does so at their own risk.

Nonprofit Driven Regional Connects will not be socially distanced events and it is likely there will be crowded environments. However, we encourage attendees to respect each individual's space and socially distance when possible. Registered attendees may leave and return to the event at their discretion.
